KNOW ALL MEN BY THESE PRESENTS, that the City of Greenville, South Carolina, a municipal corporation, in consideration of the sum of Ten and no/100 (\$10.00) Dollars to it in hand paid by Henry P. Willimon, Jr., Betty Jane Willimon Forbes and the South Carolina National Bank as Trustee under the Will of Noland Meyers, deceased, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released and by these presents do grant, bargain, sell and release unto the said Henry P. Willimon, Jr., Betty Janes Willimon Forbes and South Carolina National Bank as Trustee under the Will of Noland Meyers, deceased, their heirs, successors and assigns forever the following described property:

All that certain piece, parcel or strip of land, situate, lying and being in the City of Greenville, Greenville County, South Carolina, being a portion of Laurens Street and a portion of the northern one-half of West Coffee Street and being shown and designated as parcel "D" on plat entitled "Survey for City of Greenville, S.C." dated December 23, 1971 by Campbell and Clarkson Surveyors, Inc. and having according to said plat the following metes and bounds, to-wit:

BEGINNING at the point of the intersection of the northern right-of-way of West Coffee Street (as it formerly existed) and the western right-of-way of Laurens Street (as it formerly existed) and running thence with the western right-of-way of Laurens Street (as it formerly existed) N. 21-39 E. 66.2 feet to a point; thence S. 68-12 E. 26.19 feet to a point in Laurens Street on the new western right-of-way of Laurens Street; thence with the new western right-of-way of Laurens Street, S. 22-12 W. 95.90 feet to a point in the center line of West Coffee Street (as it formerly existed); thence with the center line of West Coffee Street (as it formerly existed) N. 69-24 W. 125.76 feet to a point; thence N. 22-12 E. 29.17 feet to a point on the northern right-of-way of West Coffee Street (as it formerly existed); thence with the northern right-of-way of West Coffee Street (as it formerly existed) S. 69-19 E. 100 feet to the point of beginning.

This conveyance is made pursuant to an agreement dated August 19, 1969 between the City of Greenville, S.C. and The Peoples National Bank, Greenville, S.C. and pursuant to certain resolutions adopted by the Greenville City Council August 19, 1969 and pursuant to the decree of the Supreme Court of South Carolina filed June 15, 1970 in the case of the City of Greenville, et al. vs. Bozeman, et al.

It is the intention of the parties hereto that the Grantees shall take an interest in the above described property equal to the interests which each of them may presently have in and to the abutting property which joins Parcel "D" immediately to the north and west.
