Hoffman and Pamela S. Hoffman, their heirs and assigns forever:

All that certain piece, parcel or lot of land with the buildings and improvements thereon, lying and being on the southerly side of Queen Ann Road, near the City of Greenville, S. C., being known and designated as Lot No. 34 on plat of Foxcroft, Section I, as recorded in the RMC Office for Greenville County, S. C., in Plat Book 4F, pages 2, 3 and 4 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southerly side of Queen Ann Road, said pin being the joint front corner of Lots 34 and 35 and running thence with the common line of said Lots S 3-49 E 165 feet to an iron pin, the joint rear corner of Lots 34 and 35; thence N 86-11 E 130 feet to an iron pin, the joint rear corner of Lots 33 and 34; thence with the common line of said lots N 3-49 W 165 feet to an iron pin on the southerly side of Queen Ann Road; thence with the southerly side of Queen Ann Road S 86-11 W 130 feet to an iron pin, the point of beginning.

This conveyance is subject to a 25 foot sewer right of way and a 10 foot drainage easement as shown on the recorded plat and to all restrictions, setback lines, roadways, easements and right of ways, if any, affecting the above described property.
