G. Proffitt, Inc., its successors and assigns forever:

All that certain piece, parcel or lot of land with the buildings and improvements thereon lying and being at the westerly intersection of Continental Drive and Castlewood Drive, near the City of Greenville, S. C. being known and designated as Lot No. 89 on plat entitled "Final Plat Revised Map #1 Foxcroft, Section II" as recorded in the RMC Office for Greenville County, S. C. in Plat Book 4N, pages 36 and 37 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwesterly side of Continental Drive, said pin being the joint front corner of Lots 88 and 89 and running thence with the common line of said Lots S 32-56 W 165 feet to an iron pin, the joint rear corner of Lots 88 and 89; thence S 54-51 E 150 feet to an iron pin on the northwesterly side of Castlewood Drive; thence with the northwesterly side of Castlewood Drive N 29-22 E 70 feet to an iron pin; thence N 25-33 E 76.7 feet to an iron pin at the westerly intersection of Continental Drive and Castlewood Drive; thence N 17-00 W 38.3 feet to an iron pin on the southwesterly side of Continental Drive; thence with the southwesterly side of Continental Drive N 57-04 W 106.1 feet to an iron pin, the point of beginning.
