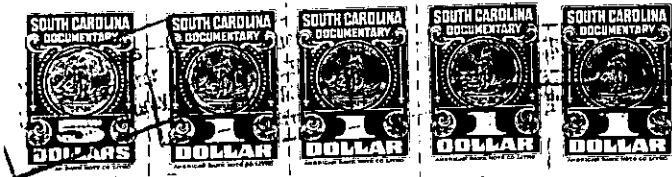
KNOW ALL MEN BY THESE PRESENTS, that ---Orville D. Park, Jr. and Pantha Weathers Park---
