sum of Ten Thousand Four Hundred and No/100 (\$10,400.00) dollars, and assumption of mortgage as set forth below, to it in hand duly paid at and before the sealing and delivery of these presents by the grantee(s) hereinafter named, (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto Clive E. Waylett and Marylee S. Waylett, their heirs and assigns forever:

All that certain piece, parcel or lot of land with the buildings and improvements thereon lying and being on the southerly side of Queen Ann Road near the City of Greenville, S. C., being known and designated as Lot No. 35 on plat of Foxcroft, Section I, as recorded in the RMC Office for Greenville County, S. C., in Plat Book 4F, pages 2, 3 and 4, and having according to said plat the following metes and bounds, to-wit:

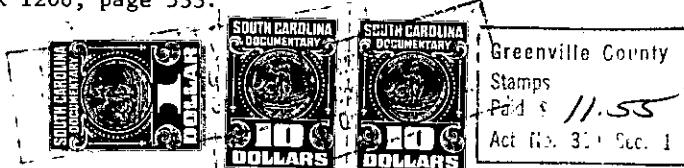
BEGINNING at an iron pin on the southerly side of Queen Ann Road, said pin being the joint front corner of Lots 34 and 35, and running thence with the common line of said lots S 3-49 E 165 feet to an iron pin, the joint rear corner of Lots 34 and 35; thence S 86-11 W 130.6 feet to an iron pin, the joint rear corner of Lots 35 and 36; thence with the common line of said lots N 3-49 W 165 feet to an iron pin on the southerly side of Queen Ann Road; thence with the southerly side of Queen Ann Road N 86-11 E 130.6 feet to an iron pin, the point of beginning.

This conveyance is subject to a 10 foot drainage easement and a 25 foot sewer easement along the side lot line, as shown on the recorded plat, to all restrictions, setback lines, roadways, easements and right of ways, if any, of record, affecting the above described property.
