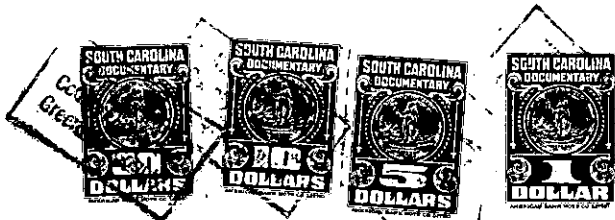
William C. Huffman and Betty Elizabeth Huffman, Their Heirs and Assigns Forever
