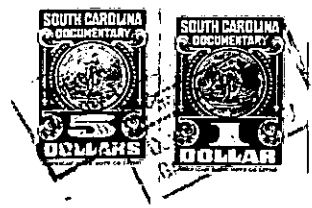
KNOW ALL MEN BY THESE PRESENTS, that Develcorp, Inc.
