All that piece, parcel or lot of land situate in the State of South Carolina, County of Greenville, on the northwestern side of Del Norte Road, being known and designated as Lot No. 306, as shown on a Plat of Del Norte Estates, Section II, recorded in the R. M. C. Office for Greenville County, in Plat Book 4N, at Page 13, and having, according to said Plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the northwestern side of Del Norte Road, at the joint front corner of Lots 306 and 307; thence with the common line of said Lots N. 46-30 W. 196.4 feet to an iron pin; thence running S. 81-00 E. 27.7 feet to an iron pin; thence running S. 83-39 W. 103.4 feet to an iron pin at the corner of Lots 305 and 306; thence with the common line of said Lots S. 55-35 E. 98.2 feet to an iron pin on the northwestern side of Del Norte Road; thence with the line of said Road S. 43-30 W. 100 feet to the point of beginning.
