All that certain piece, parcel or lot of land with the buildings and improvements thereon, lying and being on the southwesterly side of Vicki Circle, near the City of Greenville, S. C., being known and designated as Lot No. 33 on Plat No. Three Cherokee Forest, as recorded in the RMC Office for Greenville County, S. C., in Plat Book QQ, at pages 36 and 37 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwesterly side of Vicki Circle, said pin being the joint front corner of Lots 32 and 33 and running thence with the common line of said Lots S 77-53 W 210.8 feet to an iron pin, the joint rear corner of Lots 32 and 33; thence N 26-35 E 252.5 feet to an iron pin on the southwesterly side of Vicki Circle; thence along the curve of the southwesterly side of Vicki Circle S 57-15 E 59 feet to an iron pin; thence S-25-50 E 61 feet to an iron pin; thence continuing along the southwesterly side of Vicki Circle S 10-00 E 96 feet to an iron pin, the point of beginning.

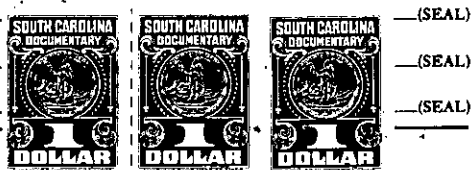
