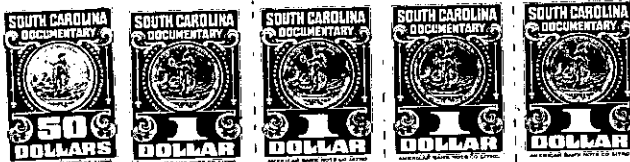
KNOW ALL MEN BY THESE PRESENTS, that **W. D. SHEDD**
