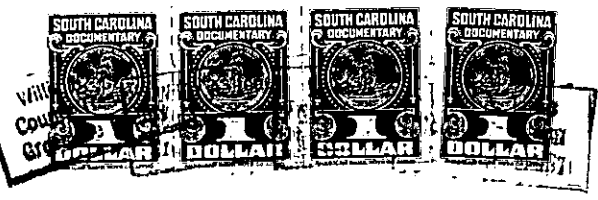
KNOW ALL MEN BY THESE PRESENTS, that we, John P. Mann and Thomas C. Brissey
