All that certain piece, parcel or lot of land, lying and being in Austin Township, Greenville County, State of South Carolina, located on the South side of the Georgia Road, west of the Town of Simpsonville, being shown as Lot No. 3 on a plat of property of Ben A. and Georgia W. Maynard, and being more fully described as follows:

BEGINNING AT A POINT IN THE CENTER OF THE Georgia Road at corner of Lot No. 2 and running thence by an iron pin 19.3 feet on line, S. 7-20 E., a total of 150 feet to an iron pin; thence S. 87-50 W. 96.7 feet to an iron pin; thence N. 2-38 W., 149.5 feet to a point in Georgia Road, iron pin back on line 19.2 feet; thence along Georgia Road N. 87-50 E., 86 feet to the beginning corner.

This conveyance is made subject to any restrictive covenants, building set-back lines, rights-of-way and easements which may affect the above described property.
