release unto JERRY L. JENKINS and JANICE W. JENKINS, their heirs and assigns forever:

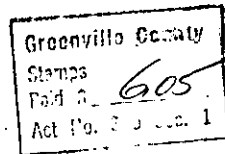
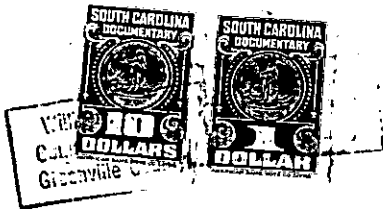
All that piece, parcel or lot of land being known and designated as Lot No. 186, Section IV, of
