H. V. Pender, his Heirs and Assigns forever,

All that certain piece, parcel or lot of land situate, lying and being in the State and County aforesaid, Oneal Township, about one mile south of Mt Lebanon Baptist Church, lying on the east side of the road known as the Mt. Lebanon Road and being the same and identical lot conveyed to me by deed from H. V. Pender January 31-1970, and recorded in the office of the R. M. C. for Greenville County in Deed Book 883 at page 529, and MMXIX having the following courses and distances, to wit:-

Beginning on a nail and cap in the said road, joint corner of the Tom Young tract, and runs thence with the common line of the said two tracts and a fence, N. 81-15 E. 24 feet to an iron pin on the east bank of the road, then continuing with the same course for a total distance of 244 feet to an iron pin by an old fence post; thence S. 66-30 E. 125 feet to an iron pin in pasture; thence E. 22-30 E. 353 feet to an iron pin in open field; thence N. 67-30 W. 335 feet to a nail and cap in the center of the said road (iron pin back on line at 23 feet); thence with the said road, S. 22-30 W. 477 feet to the beginning corner, containing three ~~##~~ (3) acres, more or less.
