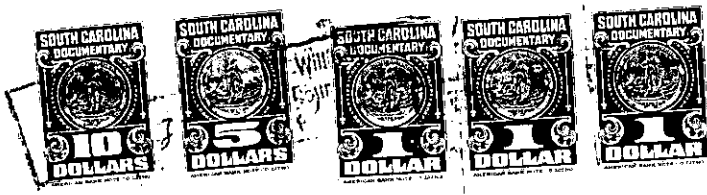

BEGINNING at an iron pin on the southeasterly side of Castlewood Drive, said pin being the joint front corner of Lots 21 and 22 and running thence with the common line of said lots S 60-06 E 175 feet to an iron pin, the joint rear corner of Lots 21 and 22; thence S 36-45 W 140.1 feet to an iron pin, the joint rear corner of Lots 22 and 23; thence with the common line of said lots N 53-25 W 165 feet to an iron pin on the southeasterly side of Castlewood Drive; thence with the southeasterly side of Castlewood Drive N 34-24 E 60 feet to an iron pin; thence continuing with Castlewood Drive N 31-24 E 60 feet to an iron pin, the point of beginning.
