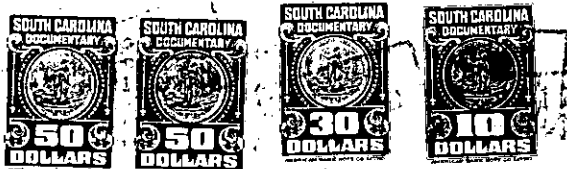
KNOW ALL MEN BY THESE PRESENTS, that ---Trav-O-Tel Corporation---

release unto Cable Corporation, its successors and assigns:

ALL that parcel or lot of land in the City of Greenville, County of Greenville,
State of South Carolina, fronting on the southeastern side of Wade Hampton
Boulevard (U. S. Highway 29) and being more particularly described according to
plat prepared by C. B. Dawsey on February 10, 1972 as follows:

BEGINNING at an iron pin on the southeastern line of the right-of-way of Wade
Hampton Boulevard (U. S. Highway 29), joint corner with lands of James M.
Gilfillin and running thence S. 37-02 E. 175 feet on the common line with lands
of James M. Gilfillin to an iron pin; thence N. 52-51 E. 68 feet to an iron pin;
thence S. 42-52 E. 335 feet to a stake, which stake is 7 feet, more or less, from
the center line of a branch; thence with the center line of said branch as the
line having a traverse line of S. 75-08 W. 274 feet to an iron pin, which iron
pin is 20 feet from the center of said branch in a northwesterly direction from
the center line of said branch; thence N. 37-22 W. 400 feet to an iron pin on
