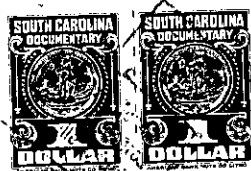
KNOW ALL MEN BY THESE PRESENTS, that We, Callie C. Gravely and Vallie C. Vaughn, Grantors,
