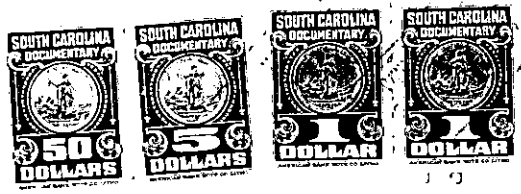
KNOW ALL MEN BY THESE PRESENTS, that -----THE ERVIN COMPANY-----
