the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto DELLA TOLBERT, her heirs and assign forever,

ALL of that piece, parcel and lot of land formerly known as the James M. Tolbert Estate and consisting of some 15.35 Acres.
