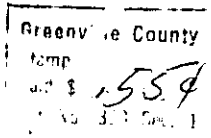
KNOW ALL MEN BY THESE PRESENTS, that We, W. Scott Conner and Elizabeth F. R. Conner

All that certain piece, parcel, or lot of land situate lying and being in Cleveland Township in the State of South Carolina, and County of Greenville, near River Falls, consisting of approximately 1.2 acres and having according to a survey prepared on March 17, 1969, and revised July 18, 1969, by Terry T. Dill, the following metes and bounds, to wit:
