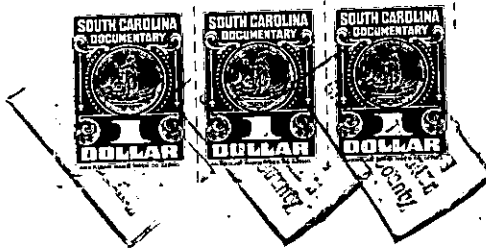

WOODROW WILSON BAILEY, HIS HEIRS AND ASSIGNS FOREVER:

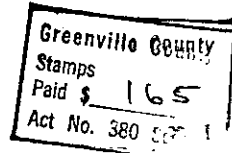
