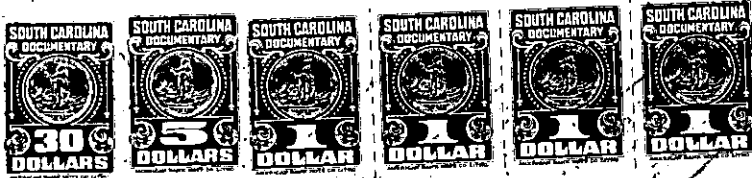
KNOW ALL MEN BY THESE PRESENTS, that I, Russell G. Moore, R. M. C.
