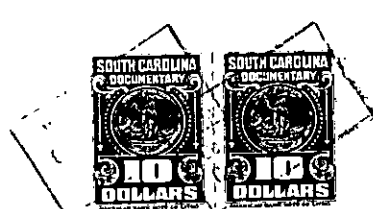
KNOW ALL MEN BY THESE PRESENTS, that Billy M. Bridwell Sitton (formerly Billy M. Bridwell) --
