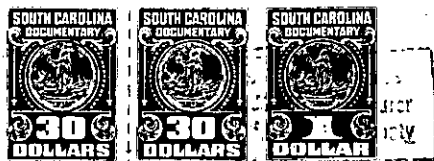
in consideration of Thirty Thousand Five Hundred (\$30,500.00) ----- Dollars,
