in consideration of Fifteen Hundred and No/100-----(\$1500.00) Dollars,

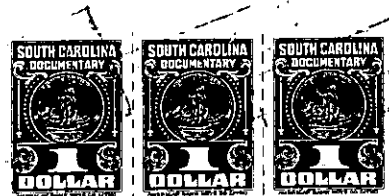

ALL that lot of land situate on the Northern side of Larosa Lane, in the County of Greenville, State of South Carolina, being shown as the Eastern half of Lot 13, on a plat of the property of Tom W. Tucker and Elsie Tucker, dated October 12, 1955, prepared by C. C. Jones and Associates, recorded in Plat Book NN, at Page 33. in the RMC Office for Greenville County and also being shown as Lot A on a plat of the property of Thomas R. Powell, dated May 19, 1972, prepared by Charles K. Dunn, recorded in Plat Book 4-Q, at Page 108, in the RMC Office for Greenville County, and having according to said latter plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northern side of Larosa Lane at the joint front corner of Lot A and Lot B, and running thence with Lot B, N. 08-46 E. 193.4 feet to an iron pin at the joint rear corner of Lot A and Lot B; thence N. 89-17 E. 57.1 feet to an iron pin; thence S. 00-48 E. 150 feet to an iron pin on Larosa Lane; thence with said lane, S. 61-47 W. 84.5 feet to an iron pin; thence still with said lane, S. 80-56 W. 13.6 feet to the point of beginning, and containing 0.28 ac.
