in consideration of Seventeen Thousand and No/100-----Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto ROBERT S. BELFORD, his heirs and assigns;

ALL that piece, parcel or lot of land, with the buildings and improvements thereon, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot 2, on Plat of Property of B. R. O'Neill, which plat is recorded in the RMC Office for Greenville County, South Carolina, in Plat Book JJ, Page 166, and being more particularly shown on Plat of Property of Shirley G. Hiles, dated May 9, 1956, by C. C. Jones & Associates, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeastern side of Edgewood Drive, joint front corner Lots 1 and 2, which iron pin is 65 feet in a southeasterly direction from the intersection of an unnamed 20 foot street and Edgewood Drive, and running thence along the joint line of Lots 1 and 2, N. 47-23 E. 167.5 feet to an iron pin, joint rear corner of said lots; thence turning and running S. 34-34 E. 89.4 feet to an iron pin, joint rear corner of Lots 2 and 3; thence turning and running along the joint line of Lots 2 and 3, S. 54-15 W. 156.4 feet to an iron pin on the northeastern side of Edgewood Drive, joint front corner of said lots; thence turning and running along the northeastern side of Edgewood Drive, N. 41-30 W. 65 feet to an iron pin; thence N. 56-49 W. 5 feet to the point of beginning.

This conveyance is made subject to any restrictions, rights-of-way, or easements that may appear of record on the recorded plat(s) or on the premises.
