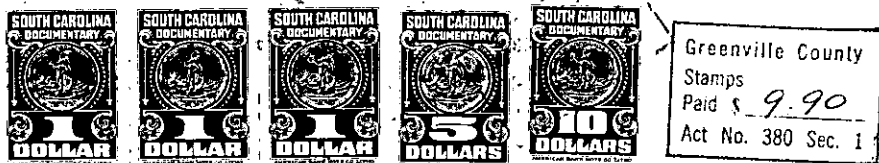

BEGINNING at an iron pin on the southwesterly side of Merrifield Court, said pin being the joint front corner of Lots 105 and 106 and running thence with the common line of said Lots S 22-35 W 180.9 feet to an iron pin, the joint rear corner of Lots 105 and 106; S 63-35 E 158.1 feet to an iron pin on the northwesterly side of Castlewood Drive; thence with the northwesterly side of Castlewood Drive N 30-48 E 70 feet to an iron pin; thence continuing with said Drive N 36-02 E 70 feet to an iron pin at the intersection of Castlewood Drive and Merrifield Court; thence N 6-41 W 34.5 feet to an iron pin on the southwesterly side of Merrifield Court; thence with the southwesterly side of Merrifield Court N 56-34 W 84 feet to an iron pin; thence continuing with said Court N 61-51 W 85 feet to an iron pin, the point of beginning.
