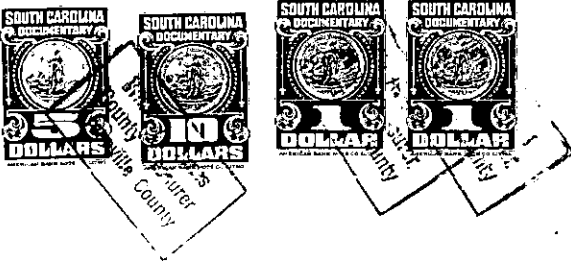
KNOW ALL MEN BY THESE PRESENTS, that Lloyd W. Gilstrap
