KNOW ALL MEN BY THESE PRESENTS, that O. R. O'SHIELDS and VIRGINIA O'SHIELDS

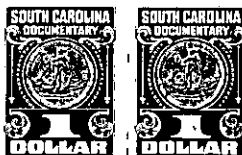
in consideration of ONE THOUSAND (\$1,000.00) and no/100-----Dollars
