All that piece, parcel or lot of land situate in the State of South Carolina, County of Greenville, on the northern side of Rockvale Drive, being known and designated as Lot No. 210, as shown on a Plat of Rockvale - Section 2, made by J. Mac Richardson, Surveyor, July, 1959, and recorded in the R. M. C. Office for Greenville County, in Plat Book QQ, at Page 109, and having, according to said Plat, the following metes and bounds, to-wit:
