the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Residential Enterprises, Inc., its successors & assigns,

All that piece, parcel or lot of land situate, lying and being on the eastern side of Elm Street in the county of Greenville, state of South Carolina, and being known and designated as a portion of Lot No. 7 on a plat of "property of Coneze C. Barner and Barbara P. Barner" dated August 8, 1967, and prepared by J. Mac Richardson, R.L.S., and having according to said plat, the following metes and bounds, to-wit:

Beginning at a point on the eastern side of Elm Street, which point is 63.3 feet from the intersection of Elm Street and Otis Street, and running thence N. 68-06 E. 139.8 feet to an iron pin; running thence S. 19-08 E. 50 feet to a point in the center of a six inch brick wall; running thence down the center of the six inch brick wall S. 62-54 W. 126.1 feet to an iron pin on the eastern side of Elm Street; running thence down the eastern side of Elm Street N. 32-45 W. 62.5 feet to the beginning corner.

As a part of the consideration for this conveyance the grantee herein assumes and agrees to pay that certain mortgage held by Collateral Investment Company in the original amount of \$14,600.00 recorded in vol. 1067 page 29 of the RMC Office for Greenville County, S. C., on which there is an approximate balance of \$12,700.00
