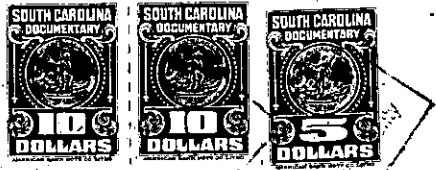
KNOW ALL MEN BY THESE PRESENTS, that Dennis O'Sullivan -----
