K. Campbell, R. L. S., November 30, 1960, and recorded in the R. M. C. Office for Greenville County in Plat Book QQ at Page 168, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Cashmere Drive, joint front corner of Lots 41 and 42 and running thence along the joint line of said lots, N. 74-14 E. 125 feet to an iron pin on the rear line of Lot 207; thence along the rear lines of Lots 207 and 206, N. 15-46 W. 72 feet to an iron pin at the rear corner of Lot 43; thence along the line of that lot, S. 74-14 W. 125 feet to an iron pin on the eastern side of Cashmere Drive; thence along the eastern side of Cashmere Drive, S. 15-46 E. 72 feet to the beginning corner.
