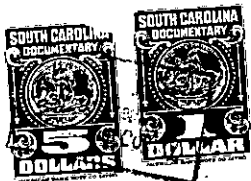

April 16, 1971, recorded in the RMC Office for Greenville County in Plat Book 4N page 38, and having according to said plat, the following metes and bounds, courses and distances, to-wit:

Beginning at an iron pin on the north side of Sunnyview Drive, joint corner of Lots Nos. 26 & 27;thence with the rear line of Lots 26 & 25, N. 20-01 E. 153 feet to an iron pin; thence S. 62-35 E. 150 feet to an iron pin; thence S. 06-25 E. 90 feet to an iron pin; thence S. 12-28 W. 62.5 feet to an iron pin on the north side of Sunnyview Drive; thence with the north side of said street N. 67-02 W. 202.5 feet to the beginning corner.

This lot is conveyed subject to protective covenants recorded in deed vol. 902 page 503 and vol. 939 page 213, and to recorded easements and rights of way or those shown on the ground.

This is a portion of the property conveyed to T. A. Huff by J. B. League by deed recorded July 12, 1919 in deed vol. 54 page 79. Subsequently T. A. Huff died testate, leaving the property to his wife, Carrie H. Huff for life with remainder to his children, James D. Huff, and Delia H. Chandler Noe, the Grantors herein.
