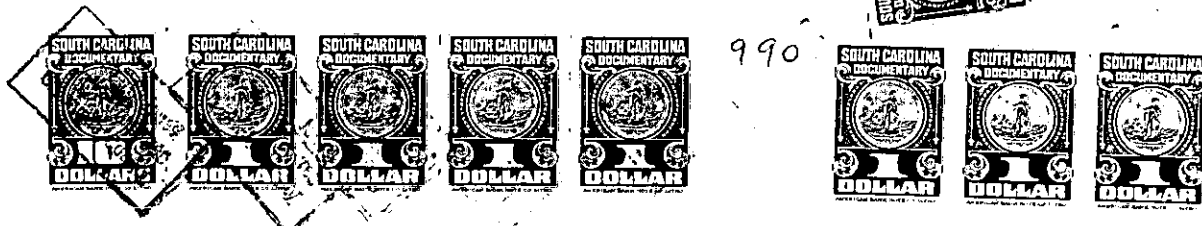

C., in Plat Book 4N, pages 36 and 37 and having, according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southerly side of Queen Ann Road, said pin being the joint front corner of Lots 19 and 20 and running thence with the common line of said lots S 3-22 W 156.8 feet to an iron pin, the joint rear corner of Lots 19 and 20; thence N 86-16 W 57.5 feet to an iron pin; thence N 85-35 W 100.1 feet to an iron pin, the joint rear corner of Lots 20 and 21; thence with the common line of said lots N 17-51 E 175.5 feet to an iron pin on the southerly side of Queen Ann Road; thence with the southerly side of Queen Ann Road S 75-22 E 57.5 feet to an iron pin; thence continuing with said Road S 82-36 E 57.5 feet to an iron pin; the point of beginning.
