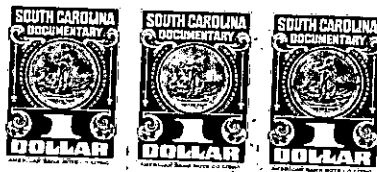
KNOW ALL MEN BY THESE PRESENTS, that ELIZABETH RIDOLE

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release

ALL that piece, parcel or lot of land situated, lying and being on the eastern side of Glendale Street, near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 35 as shown on the plat of Glendale Heights recorded in the R.M.C. Office for Greenville County, South Carolina in Plat Book KK at page 143 and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the western side of Glendale Street at the joint front corner of Lots Nos. 35 and 36 and running thence with the line of Lot No. 36, S. 83-15 W. 130 feet to an iron pin; thence with the rear line of Lot No. 61, N. 6-45 W. 70 feet to an iron pin in the rear line of Lot No. 34; thence with the line of Lot No. 34, N. 83-15 E. 130 feet to an iron pin on Glendale Street; then with the western side of Glendale Street, S. 6-45 E. 70 feet to the point of beginning.
