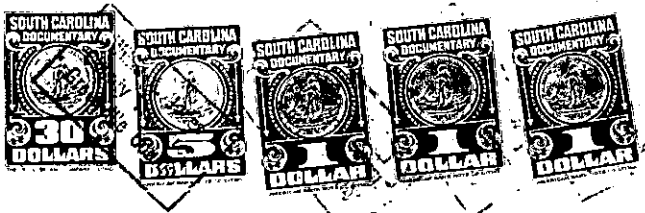
CORNELL MIMS, HIS HEIRS AND ASSIGNS, FOREVER:
