the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

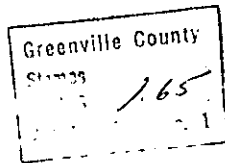
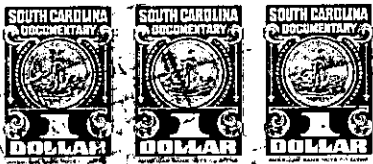
Deacons of Locust Hill Baptist Church, acting as Trustees of Church Property and their Successors in office, as Trustees of Locust Hill Baptist Church forever:
