in consideration of **SIX THOUSAND FIVE HUNDRED AND NO/100THS (\$6,500.00)** ----- Dollars,

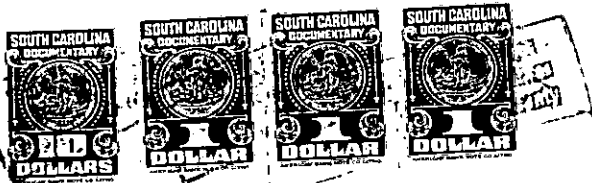
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto
