Beginning at an iron pin on the southeast side of Archdale Drive, the joint front corner of Lots 24 & 25, and running thence with the joint line of said lots S. 64-08 E. 170 feet to an iron pin, center of Duke Power Company right of way; thence with the center of said right of way S. 29-18 W. 95 feet to an iron pin on the north side of Moriston Road; thence with the north side of said street N. 67-17 W. 146.3 feet to an iron pin; thence N. 19-21 W. 33.4 feet to an iron pin on the southeast side of Archdale Drive; thence with the southeast side of said street N. 29-18 E. 79.7 feet to the beginning corner.
