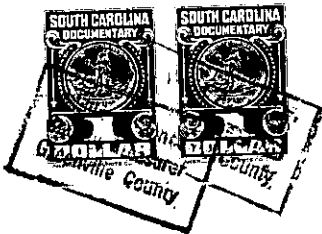
KNOW ALL MEN BY THESE PRESENTS, that ESTHER LYNCH, Grantor,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release
unto E. R. MVKELVER, Grantee:

ALL my ONE-SEVENTH (1/7) interest in title to that piece, parcel or lot of land situated, lying and being on the Southeastern side of Jackson Drive, in the community known as Brutontown, near the city of Greenville in the County of Greenville and the State of South Carolina, having the address of 104 Jackson Drive and having the following metes and bounds according to a survey and plat thereof made by C. M. Furman, Engineer, on April 15th, 1927, to wit:
