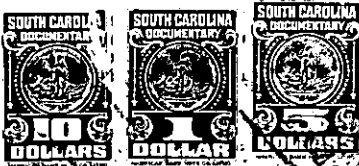
KNOW ALL MEN BY THESE PRESENTS, that Lewis P. McDonald -----
