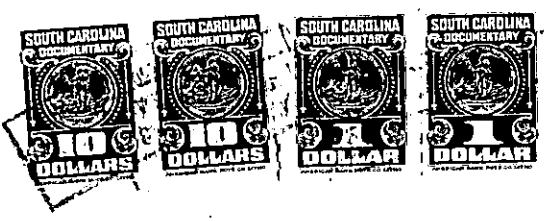

All that piece, parcel or lot of land, with the buildings and improvements thereon, situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as the Southwest portion of Lot 17 on Plat of Croftstone Acres as shown on Plat thereof recorded in the RMC Office for Greenville County in Plat Book E, pages 35 and 36, and having, according to said plat and a more recent survey entitled "Property of J. J. and Irene J. Thruston" prepared by Thomas M. Welborn May 10 1948, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the North side of Wedgewood Avenue the joint corner of Lots 17 and 18, and running thence with the joint line of said lots, N. 23-29 W. 180 feet to an iron pin; thence N. 78-30 E. 106.5 feet to an iron pin, corner of property now or formerly of L. E. Lincoln; thence with the line of said property S. 12-45 E. 177 feet to an iron pin on the North side of Wedgewood Avenue; thence with the North side of Wedgewood Avenue S. 78-41 W. 70 feet to the beginning corner.
