the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release
unto

Hugh H. Drake and Maxine H. Drake, their heirs and assigns forever:

ALL our right, title and interest, the same being an undivided four/ninths
(4/9ths) interest in and to:

ALL that piece, parcel or lot of land in the County of Greenville,
State of South Carolina, located on the southern side of Highway
No. 276 near Blythe Shoals, bounded on the North by Highway No. 276,
on the East and South by Cleveland property and on the West by property
of Robinson and property of Street, and according to a plat entitled,
"Property of Hugh Drake" dated June 10, 1972, by Terry T. Dill, R.L.S.,
recorded in Plat Book 44, at page 83, of the RMC Office for
Greenville County, having the following metes and bounds, to-wit:
