ALL that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, on the north side of Alta Vista Circle being known and designated as Lot 137 of a subdivision known as Coleman Heights as shown on plat thereof made by Terry T. Dill, February, 1958, recorded in the RMC Office for Greenville, S. C. in Plat Book RR, Page 115, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the north side of Alta Vista Circle at the joint corner of Lots 136 and 137 and runs thence along the line of Lot 136 N. 02-35 E. 145.7 feet to an iron pin; thence along the line of Lot 43 N. 73-12 E. 150 feet to an iron pin; thence along the line of Lot 42 N. 68-04 E. 48.3 feet to an iron pin on the west side of a 20-foot alley; thence along said 20-foot alley S. 11-02 W. 220.9 feet to an iron pin on the north side of Alta Vista Circle; thence along Alta Vista Circle N. 86-20 W. 153.9 feet to the beginning corner.

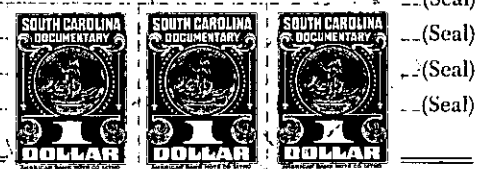
