I, FRANK P. McGOWAN, JR., as Master in and for the County aforesaid, SEND GREETING:

WHEREAS, Mary C. Reid,

on or about the 1st day of August in the year of our Lord nineteen hundred and seventy-two exhibited her

demanding relief as to the real estate described in the complaint: and the cause being at issue, came on to be heard on the 28th day of August 1972,

and such proceedings were had therein as resulted in a decree of the said Court, whereby it was adjudged and decreed that the said real estate hereinafter mentioned and described, be conveyed by FRANK P. McGOWAN, JR., as Master in and for the County aforesaid, to Charles L. Reid, Jr.,

NOW, Therefore, Know all Men by these Presents, that I, FRANK P. McGOWAN, JR., as Master, in and for the County of Greenville aforesaid, by virtue of the aforesaid decree, and in partition,

HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release unto the said Charles L. Reid, Jr.:

ALL that certain piece, parcel or lot of land in the County of Greenville, State of South Carolina, containing 3.37 acres, more or less, situate, lying and being on the south side of State Park Road, being known and designated as Lot No. 5 as shown on a plat entitled "Mary C. Reid, et al Owner" made by Dalton & Neves Company, dated June 8, 1972, said plat recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book 4R, page 25, and the property having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the south side of State Park Road at the joint front corner of Lot No. 4 and Lot No. 5 and running thence S. 38-02 E. 980.9 feet to an iron pin; thence S. 49-42 W. 150 feet to an iron pin; thence N. 38-00 W. 974.7 feet to an iron pin on State Park Road; thence along State Park Road, N. 49-43 E. 75 feet to an iron pin; thence N. 44-54 E. 75 feet to an iron pin, the point of beginning.
