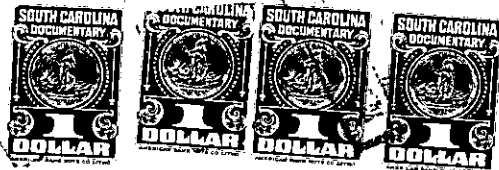

All those pieces, parcels or lots of land situate, lying and being in the County of Greenville, State of South Carolina, on the northern side of Roscoe Drive and being known and designated as Lots Nos. 48, 49, and 50 on Plat of Pleasant Heights Development and recorded in the RMC Office for Greenville County in Plat Book "T" at Page 275 and having, according to said Plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Roscoe Drive at the joint front corner of Lots 47 and 48 and running thence along said drive S. 78-30 E. 300 feet to an iron pin; thence along the joint line of Lots 50 and 51 N. 5-00 E. 270 feet to an iron pin; thence N. 84-30 W. 300 feet to an iron pin; thence S. 5-00 W. 200 feet to the point of beginning.

The above are the same lots conveyed to J.A. Kinion and the grantee by deeds recorded in Deed Book 786 at Page 29 and Deed Book 656 at Page 218. J. A. Kinion died testate on June 29, 1971, devising his interest in said property to the grantee and his children. The grantor is one of the children of J. A. Kinion.
