ALL of that lot of land in the County of Greenville, State of South Carolina, in Bates Township, containing 5.17 acres, more or less, and being a portion of the property of James H. and Annie Mae Bailey, and also property of Violet S. Balding, and having the following metes and bounds, to-wit:

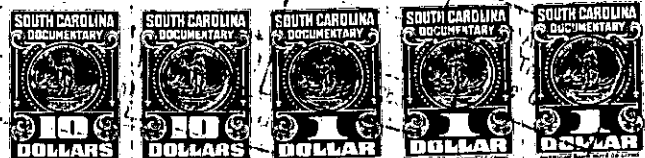
