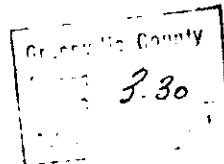
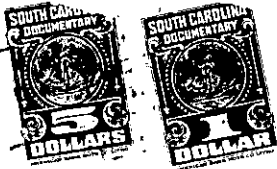

BEGINNING at an iron pin on the northeasterly side of Continental Drive, said pin being the joint front corner of Lots 80 and 81; and running thence with the common line of said lots N. 39-38 E. 203.2 feet to an iron pin, the joint rear corner of Lots 80 and 81; thence N. 45-00 W. 92 feet to an iron pin; thence S. 46-15 W. 173.2 feet to an iron pin on the northeasterly side of Continental Drive; thence with the northeasterly side of Continental Drive S. 43-45 E. 36.2 feet to an iron pin; thence continuing with said Drive S. 47-06 E. 78.8 feet to an iron pin, the point of beginning.
