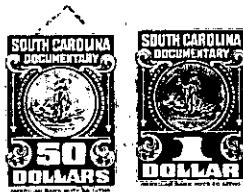

the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and
release unto **Investment Properties, Inc.**

ALL that certain piece, parcel or lot of land situate, lying and being in
the State of South Carolina, County of Greenville, on the westerly side of
access road near interchange of I-85 and U.S. Highway 25, as shown on a
plat entitled "Property of Domar Corporation, Inc.", prepared by Campbell
& Clarkson, Surveyors, and having according to said plat, the following
metes and bounds, to-wit:

BEGINNING at an iron pin on the westerly edge of the right-of-way
of an access road, which iron pin is located 220 feet in a northerly
direction along the western edge of the right-of-way of said access road
from the intersection of said road and Pine Creek Drive, and running
thence from said point of beginning S. 81-06 W. 162 feet to an iron pin;
thence N. 3-03 W. 125.7 feet to an iron pin; thence N. 81-06 E. 160 feet
to an iron pin on the westerly edge of the right-of-way of said access road;
thence along the westerly edge of the right-of-way of said access road, the
following courses and distances: S. 2-12 E. 63.5 feet and S. 5-54 E. 62
